ATTENTION EXHIBITORS

POLICY ON STANDARDS OF BEHAVIOR BY ABTC MEMBERS ATTENDING NATIONAL (AND OTHER) SPECIALTY SHOWS

The show site will be available to exhibitors on Sunday, April 30, 2006 at 3:00 pm. Dogs must be removed from the show site by 11:00 am Sunday, May 7, 2006.

The ABTC has an excellent history of maintaining its Specialty headquarters & show site in good condition. Rings, grooming area & hotel rooms occupied by its members are expected to be left with no appreciable damage, and as clean as possible, after the Specialty is over. As a measure of insuring that this standard will be met, the Club, as a matter of policy sets forth the following standards of behavior.

- No dog should be left uncrated in a hotel room in the absence of the room occupants at any time.
- Dogs that constitute a nuisance to other occupants of the hotel by continual barking or howling, may subject their owner to being removed by the hotel.
- There will be no extensive grooming of dogs in the hotel rooms. Grooming will be permitted only in the areas set aside for that purpose.
- No dogs should be washed in hotel bathtubs, and hotel towels should not be used on dogs for drying them or any other purpose.
- The external and internal premises of the hotel and show site shall be kept free of debris and feces caused by the presence of dogs attending the Specialty.
- The Club will provide a committee to inspect rooms upon member checkout, either separately from, or in concert with, designated members from the hotel staff. Should any room or its contents exhibit signs of unusual wear or damage because of the presence of a dog or dogs, the occupant of that room may be held up to censure by the Club and shall recompense the hotel for all damages. Offenders may be censured, held in suspension of membership or expelled from membership in the ABTC should the circumstances warrant.

While the ABTC cannot assume legal responsibility for the actions of individual persons attending one of its national specialties, it <u>does</u> assume ethical responsibility for their actions. It will make every effort to assure that any offending person make redress to the hotel or show site in the event that he/she is responsible for damage to the premises. The ABTC urges its members to carefully inspect their rooms prior to checkout. All National Specialty Attendees are expected to adhere to these Standards.

The Specialty Committee additionally requires that:

- Exhibitors are not to bring litters of puppies to the Show Headquarters.
- Non-ABTC members attending the 2006 ABTC National Specialty will adhere to these standards.
- · All dogs will be on a leash at all times.
- By exhibiting at the National Specialty, you are agreeing to abide by the rules established by the show committee and the host hotel. Failure to follow these rules will result in removal from the host hotel.

ADDITIONAL SHOW INFORMATION

The Show Committee may make and enforce any rules they deem necessary, to insure the continuity of the show & good will of the hotel.

The club reserves the right to substitute a prize of equal or greater value.

All trophies must be claimed they day of the show - none will be mailed.

This club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

A Recording Fee of 50 cents and \$1.50 AKC Event Service Fee will be required for each dog entered at any Licensed or Member Club Show or Obedience Trial. If a dog is entered in more than one class in the show, the Fees are to be collected on the first entry only. (American Kennel Club Rule, Chapter 11, Section 2). A \$3.00 AKC Recording Fee will be required for each entry in Rally. (American Kennel Club Rule, Chapter 1, Section 3) These Fees are to be collected by the show giving Club and paid to the American Kennel Club.

CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS.

There will be no refund for duplicate entries.

Dogs need be present only for scheduled judging and will be released if not needed for further judging.

Dogs allowed in rings during judging only.

Dogs must be ready for judging. Neither the club nor its Superintendents will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. **Owners or agents alone are responsible for the presence of their dogs in the judging rings.**

The Club reserves the right to substitute a prize of equal or greater value.

All trophies must be claimed the day of the show - None will be mailed.

RETURNED CHECKS/INVALID CREDIT CARDS do not constitute a valid entry fee. Fees must be paid in guaranteed funds. Checks will not be accepted. The Superintendent will add a collection fee to the amount of each returned check & credit card. Subsequent returned checks & credit card from the same exhibitors may result in their being put on a CASH ONLY basis.

Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge or barred from competition by action of the Show Committee.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or the Superintendent.

The show giving Club, the Show Superintendent, their agents, employees, etc, assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to children.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees, signatures or the "Agreement" on the reverse side of the Official AKC Entry Form.

Changes, additions or corrections to entry forms must be received in writing or by telegram prior to close of entries. Those received by telephone are not acceptable.

Refunds of \$3.00 & less will not be issued due to the costs of processing.

An administrative fee of \$2.00 will be charged for all cancellations or changes made prior to closing of entries.

The showing of dogs whose Champions are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a Championship according to the owner's records.

NON-REGULAR (ADDITIONAL) CLASSES Involving Single Dog Entries

VETERAN DOG CLASS - A Class for Dogs eight (8) years or older.

VETERAN BITCH CLASS - A Class for Bitches eight (8) years or older.

HERDING TITLED DOG CLASS - A Class for Dogs to honor those dogs that have distinguished themselves in the job for which the Belgian Tervuren was bred. Dogs are eligible to compete if they have one or more AKC Herding Titles (HY, PT, HS, HSAd, HSAs, HSAc, HSBd, HSBs, HSBc, HSCs, HI, HIAd, HIAs, HIAc, HIBd, HIBs, HIBc, HICs, HX, HXAd, HXAs, HXAc, HXBd, HSBs, HXBc, HXCs, HC) by the close of entries. Herding Instinct Certificates (from AKC or ABTC) do not meet the eligibility requirements of this class. Entries may be neutered or spayed & may not have a Championship. Winners will be eliqible to compete in Best of Breed.

HERDING TITLED BITCH CLASS - A Class for Bitches to honor those bitches that have distinguished themselves in the job for which the Belgian Tervuren was bred. Bitches are eligible to compete if they have one or more AKC Herding Titles (HY, PT, HS, HSAd, HSAs, HSAc, HSBd, HSBs, HSBc, HSCs, HI, HIAd, HIAS, HIAC, HIBd, HIBs, HIBc, HICs, HX, HXAd, HXAs, HXAC, HXBd, HSBs, HXBc, HXCs, HC) by the close of entries. Herding Instinct Certificates (from AKC or ABTC) do not meet the eligibility requirements of this class. Entries may be neutered or spayed & may not have a Championship. Winners will be eligible to compete in Best of Breed.

NON-REGULAR (ADDITIONAL) CLASSES Involving Multiple Dog Entries

As the judge's decision in the Non-Regular Classes involving Multiple Dog Entries is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won these classes.

STUD DOG CLASS - For Stud Dogs and two of their Get. Stud Dogs must be entered in the Stud Dog Class & must be shown in the ring with their Get. The owner of the Stud Dog need not necessarily be owner of the get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy or the standard for its Breed. Get must be entered in a regular class, Best of Breed Competition or some other non-regular class.

BROOD BITCH CLASS - Same as for the Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get.

BRACE CLASS - Two dogs of the same Breed or Variety of Breed with one or more common owner and both dogs must be entered in another class.

SELECT AWARDS

The judge may, at her discretion, recall into the ring approximately 10% of all dogs/bitches eligible for Best of Breed competition, to be awarded a Hand Beaded Ribbon and ABTC Gold Medallion. These awards are reserved for those quality animals the Judge feels are worthy of final consideration for Best of Breed.

Tervuren entered in Best of Breed eligible conformation classes (class dogs, class bitches, Best of Breed, non-regular veteran dog and veteran bitch) are not eligible to participate in Honor Parade. A Show Secretary, Show Chairperson and any Specialty Judge who has completed their assignment may enter their eligible Tervuren in the Honor Parade.

Per ABTC Guidelines: The **Rescue Parade** is the ABTC's venue to honor those Tervuren which were left with no family or responsible party to look after them. These Tervuren have found new homes and are examples of what a Belgian Tervuren is capable of when handled with love and care by their adoptive owners who we also honor. The **Rescue Parade** is limited to dogs & bitches that have been placed through the ABTC Rescue committee, or other rescue organizations. All Rescue dogs shall be altered. Dogs that have been "rehomed," returned to the breeder, and/or through the breeder has found a new home, are not eligible for the Rescue Parade. Rescue dogs are not eligible to compete in any Conformation event at the National, but may be entered in any Performance event as well as the Rescue Parade. There is no age limitation.
