**From U.S. Rt. 15** – Take York Rd. (Rt. 30) west toward Gettysburg. Turn right on Shealer Rd (Hampton Inn on corner). At 1.1 miles, Shealer becomes Boyd's School Road. Continue 0.8 miles to Table Rock Rd. Turn right. Go 1.4 miles to Redding Farm (on right). Drawing will be held at Redding Farm.

## GENERAL INFORMATION & TEST RULES

- 1) Eligibility - This test is for Belgian Tervuren that are not less than six months of age and otherwise eligible for a particular test. A dog must have a TD title in order to enter the TDX test.
- 2) Bitches in season - Bitches in season MAY participate, provided that the test secretary and judges are notified of same prior to the drawing of tracks. The last track(s) laid shall be for the bitch(es) in season. If there is more than one bitch in season, a second draw for these bitches will be held. Bitches in season will be allowed to participate in a test only after all the other dogs and bitches have been tested.
- 3) Drawing for entry acceptance - A drawing will be held on Wednesday, April 5, 2006 at 6:30 pm at the home of the trial secretary to determine which entrants will participate in the test and the position of excess entrants on the alternate list.
- 4) Drawing for track position - The draw for running order of the tracks for the TD and TDX tests will be held at 9:00 am on Sunday, April 30, 2006 at Redding Farm. Judging will begin as soon after the draw as the first track is ready.
- 5) Test Hours & Rules - The tracking test hours are from 6:00 am to 5:00 pm on Tuesday, May 2, 2006. All campus rules and regulations will be observed. Dogs must remain on lead and under control at all times.
- 6) Refunds - Entry fees will be refunded to alternates who decline to be placed on the alternate list. Also, entry fees of alternates who do not participate in the test will be refunded. Entry fees will not be refunded to a scheduled entrant who is absent on the test day unless an alternate is present and runs in the place of the absent dog.
- 7) Please note - According to the AKC Tracking regulations, "A dog that is allowed to run free and off-lead, at any time before the test, during a test, after failing or after the completion of its track, shall be failed and excused."
- 8) Practicing at the test sites - You may practice at the test sites, however, we ask that no dogs be on the test sites within 3 days of the test. Only test officials and personnel should be at Redding Farm on the Monday before the test. Please keep dogs on lead and clean up after them.
