**Directions to Trial Site**

- ◆ From Interstate 65 North or South, take exit 61 (Spring Hill).
- ◆ Turn east on Tennessee 248 (Peytonsville Road) for 0.3 miles.
- ◆ Then take the first left on to Long Road, and travel 0.3 miles.
- ◆ Williamson County AgEXPO Park is on your right.
- ◆ The most convenient parking for obedience rings is to the east (right) of the main building.

**Directions to Emergency Clinic**

- ◆ From the AgEXPO Park, turn left on to Long Road, then right on Tennessee 248 (Peytonsville Road), to Interstate 65.
- ◆ Take Interstate 65 north to exit 65, and turn west on Tennessee 96 (Murfreesboro Road) for about 0.3 miles.
- ◆ Turn left (south) on South Royal Oaks Boulevard and travel about 1.3 miles until you reach the clinic.
