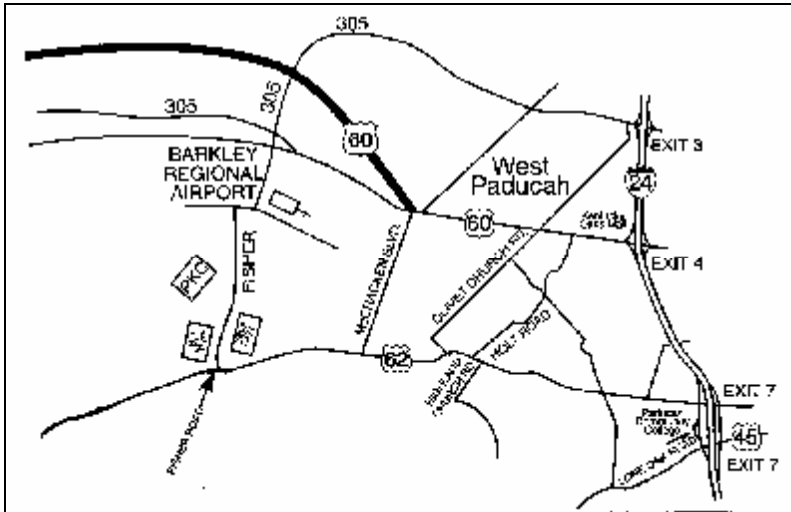


Directions

The Paducah Kennel Club show site and club building are located west of Interstate 24.

From the North: Take Exit 4 off Interstate 24. Take U.S. Route 60 west to Kentucky 305. Turn left (south) on Kentucky 305. You will pass the airport on your right and go through two stop signs. Continue on Kentucky 305 (Fisher Road) to the Paducah Kennel Club sign on your right, about 2 miles past the airport.

From the South: Take Exit 7 off Interstate 24. Take U.S. Route 62 west approximately 7.5 miles to Fisher Road. There is a BP Mart on the corner of U.S. 62 and Fisher Road. Turn right on Fisher Road and travel approximately ¼ mile to the Paducah Kennel Club sign on your left.

Please contact the individual hotels to verify acceptance of dogs; and size and number of dog limits, or any pet deposits or fees that may be required.

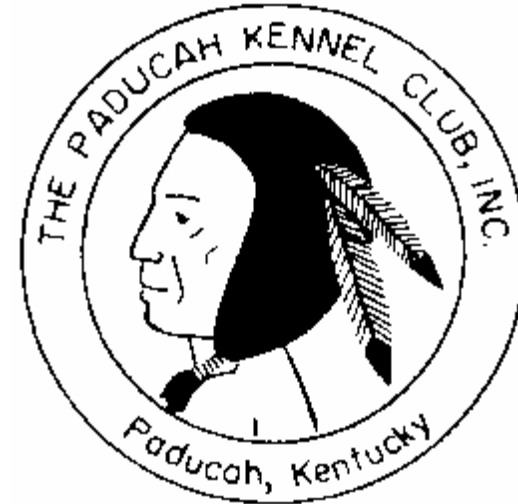

Setup Information

The Trial site will be available to exhibitors and vendors for set up after 10:00 A.M. on Thursday, October 26. *There is limited inside crating, most crating is outside under cover. Crating during the Rally trial must be outside!*

Move-Up Information

Prior to the Trials: Dogs shall be moved up to a higher obedience or rally class at the request of the owner, as a result of qualifying for an obedience or rally title, provided that the request is made to the Trial Secretary not later than noon Eastern Standard Time on Monday, October 23, 2006. E-mail notice is acceptable.

Day-to-day: Move-ups between days will be allowed. The request to move-up must be made to the Trial Secretary no later than one hour after the conclusion of obedience classes.
