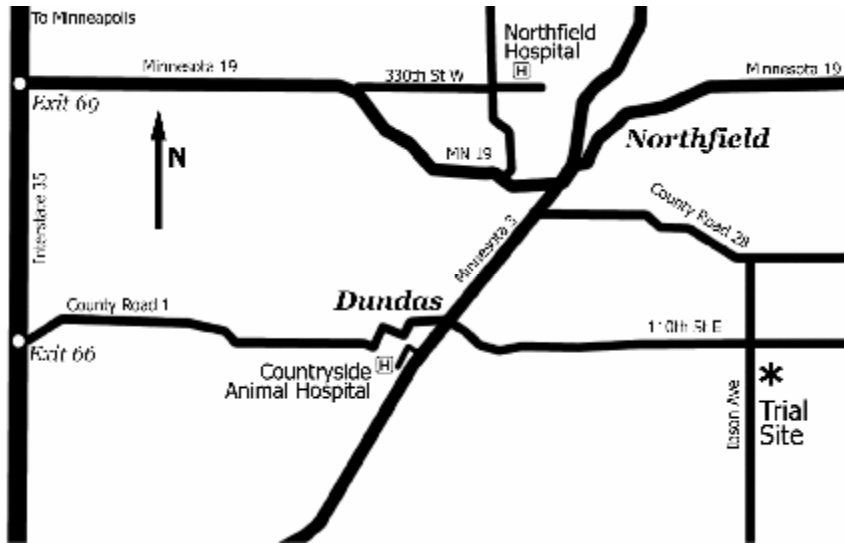


Directions to Trial Site

Lawrence Farm is located approximately 30 miles south of Minneapolis, Minnesota.

- From Interstate 35, take exit 69 (Northfield; New Prague).
- Go east on Minnesota 19 (Lonsdale Boulevard) and travel about 7 miles.
- Turn right (south) on Minnesota 3 (Dahomey Avenue), and go about 0.5 miles.
- Turn left (east) on County Road 28 (Woodley Street), traveling about 2.5 miles.
- Turn right (south) onto Ibson Avenue, and go about 1.2 miles to the trial site on your right.
