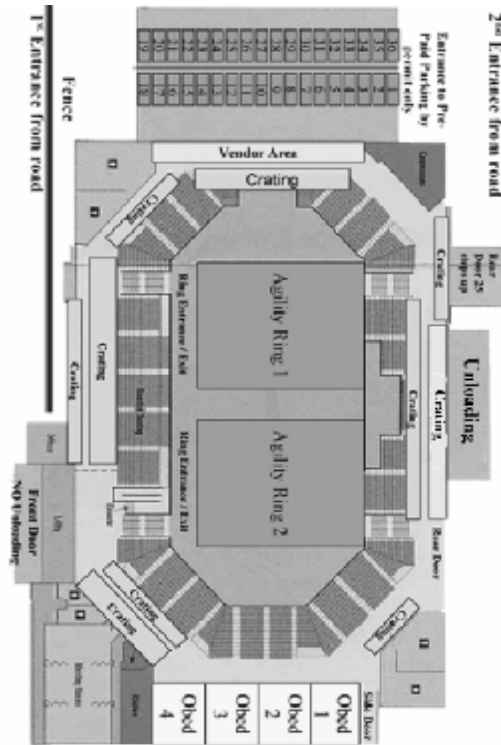


Directions to Emergency Clinic

- ♦ From the AgEXPO Park, turn left on to Long Road, then right on Tennessee 248 (Peytonsville Road), to Interstate 65.
- ♦ Take Interstate 65 north to exit 65, and turn west on Tennessee 96 (Murfreesboro Road) for about 0.3 miles.
- ♦ Turn left (south) on South Royal Oaks Boulevard and travel about 1.3 miles until you reach the clinic.

- ♦ Consider stacking your crates.
- ♦ Share a mat; make a friend.
