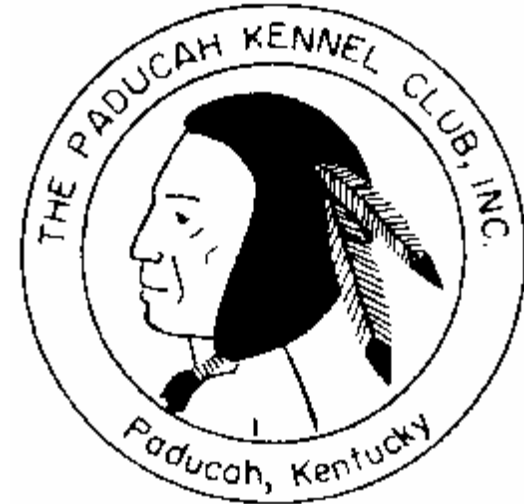

Directions

The William “Bill” Cherry Agricultural Exposition Center is located on College Farm Road in Murray, Kentucky one mile west of the Five Points intersection of 16th and Chestnut Streets and the Murray State University Campus. The Expo Center is across the street from the Calloway County High School.

From the Northeast via the Western Kentucky Parkway (i.e. Evansville, Louisville or Lexington): Take the Western Kentucky Parkway until it ends. Continue west to Interstate 24 and proceed west to the Purchase Parkway. From there, continue as “From the East or West via Interstate 24.”

From the East or West via Interstate 24 (i.e. Paducah, Saint Louis or Nashville): From Interstate 24, take Exit 25A. Take the Purchase Parkway and proceed south approximately 15 miles to Exit 41 (Murray State University / U.S. Route 641 By-Pass South). Exit onto U.S. Route 641 and follow it south about 18.5 miles to Chestnut Street (Kentucky 1327). Turn right (west) on Chestnut Street and drive until you come to a five-way stop light. Continue straight on College Farm Road. The Exposition Center will be on your left approximately one mile down College Farm Road.

From the East or West via Interstate 40 (i.e. Memphis): From Interstate 40, take Exit 126 (Camden / Paris / Parsons). Follow U.S. Route 641 north approximately 60 miles to Murray, Kentucky. In Murray, turn left (west) on Main Street (Kentucky 94). Drive approximately four blocks to 16th Street (Kentucky 822). Turn right and follow 16th Street to College Farm Road. Turn left on College Farm Road and proceed until you see the Expo Center on your left.

The match will be offered Friday and Saturday after the trial, to tentatively start in the early afternoon. Times will be posted at the trial.

Entries will be accepted each day up until 4:30 P.M.

No food in the rings, please. There will be someone available to time your session and to watch dogs during sits and downs. Bring a friend with you to help set your jumps and call your heeling patterns.

We will break for sits and downs when needed.
