DIRECTIONS TO VETERINARIAN'S OFFICE

From the trial site, go north on Ibson Avenue for about 0.2 miles. Turn left (west) on 110th Street East for 2.3 miles. Turn left (southwest) on Minnesota 3 (Faribault Boulevard) and travel 0.4 miles. Turn right (northwest) onto Hester Street, then immediately turn left (southwest) onto Schilling Drive. Travel about 0.3 miles to the Clinic.

DIRECTIONS TO HOSPITAL

From the trial site, go north on Ibson Avenue for about 1.2 miles. Turn left (west) on County Road 28. Travel 2.6 miles to Minnesota 3, turn right (northeast) and travel 0.5 miles. Turn left (west) onto Minnesota 19 (5th Street West). After 0.8 miles, turn right (northeast) onto Forest Avenue. Travel only 0.1 miles to County Road 43 (Lincoln Street). Turn left (north) on CR 43, following it, as it turns left onto Cedar Avenue, for a total of 1.2 miles. Turn right (east) onto North Avenue to the Hospital.

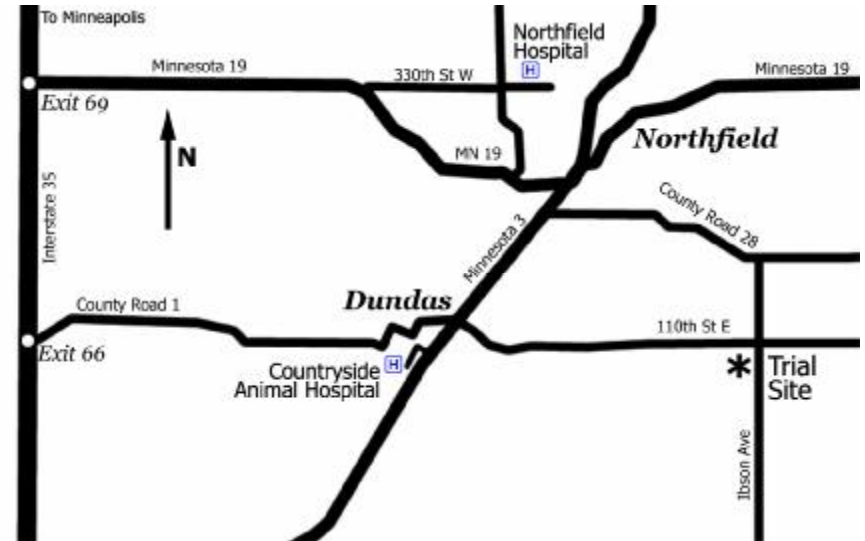

Directions to Trial Site

Lawrence Farm is located approximately 30 miles south of Minneapolis, Minnesota.

- From Interstate 35, take exit 69 (Northfield; New Prague).
- Go east on Minnesota 19 (Lonsdale Boulevard) and travel about 7 miles.
- Turn right (south) on Minnesota 3 (Dahomey Avenue), and go about 2.5 miles.
- Turn left (east) on County Road 1 (110th Street East), traveling about 0.5 miles to the stop sign.
- Go straight (east) through the stop sign on County Road 81 (110th Street East)
- Turn right (south) onto Ibson Avenue, and go about 0.2 miles to the trial site on your right.
